# TERMS OF REFERENCE OF ASSIGNMENT N°1

Evaluation of the 2012 ABS strategy and action plan of Cameroon, development of the updated strategy, and a framework to guide the integration of the Nagoya Protocol on ABS into the country's NBSAP III

Reference in the year 1 annual work plan: activities, 1, 2,3, 4, 44.

### I. CONTEXT

Within the framework of the implementation of the Nagoya Protocol in Cameroon, a national ABS strategy was developed in 2012 by the government with the involvement of key stakeholders, as a translation of the regional ABS strategy of the Central African Forests Commission (COMIFAC) to the national level.

The overall objective of this strategy was to guide the development of a national ABS framework in line with the provisions of the Convention on Biological Diversity (CBD) and the Nagoya Protocol on ABS. More specifically, it was designed to:

- enable Cameroon to define administrative procedures for access to genetic resources and the fair and equitable sharing of benefits arising from their utilization;
- define mechanisms for identifying and involving the various stakeholders;
- identify actions to be taken to develop a legal, institutional and regulatory framework;
- identify actions/activities to be carried out to strengthen the capacities of ABS stakeholders

- provide guidelines for integrating the valorization of genetic resources and associated traditional knowledge into national development policies;
- define how the strategy will be implemented;

The national ABS strategy was developed in 2012 and an action plan for its implementation for the period 2016-2019 was adopted in 2016. This country's ABS strategy and its action plan are currently outdated and needs updating. The evaluation of its implementation will enable decision-

makers and interested parties to assess the achievements and the constraints that have limited it, and to take the necessary corrective measures.

Also, in December 2022, the Parties to the Convention on Biological Diversity adopted the historic Kunming-Montreal Global Biodiversity Framework and its associated decisions. It comprises four goals for achieving the 2050 vision of "living in harmony with nature". Goal C and Target 13 cover access and benefit-sharing from the utilization of genetic resources, associated traditional knowledge, and digital sequence information.

As part of the efforts to sustain the ABS framework in Cameroon, the project entitled "Support to Nagoya Protocol implementation, research, and development, on Biodiversity value chain for smallholders in the South-West and Far North Regions of Cameroon ", has been approved by the Global Environment Facility (GEF). The project aims to support the operationalization of the ABS national framework, by enabling access to genetic resources and associated traditional knowledge that accrue tangible national and local economic benefits from their commercial utilization in a fair, equitable, and sustainable manner.

The project planned among other activities to assess the level of implementation of the 2012 ABS strategy, develop an updated ABS strategy and action plan and a framework for financing, as well as a National Strategy for conservation and sustainable use of biodiversity, genetic ressources, including associated traditional Knowledge, and incorporate into the National Biodiversity Strategies and Action Plans (NBSAP) III iteration. These strategies are to be developed in perfect alignment with the 2022 Kunming-Montreal Global Biodiversity Framework.

This is the context that justifies the formulation of the present terms of reference. The Project is looking for a consultant to carry out this assignment

#### II. OBJECTIVES

Through this assignment, the project seeks to develop a framework guide the integration of the Nagoya Protocol on ABS into the country's NBSAP III, assess the level of implementation of the 2012 ABS strategy and action plan of Cameroon, and develop an updated strategy.

More specifically, the assignment will:

- Propose a mechanism for the integration of the Nagoya Protocol on ABS into the country's NBSAP III iteration;
- Identify the activity planned in the 2012 ABS strategy and its action plan;
- Evaluate the implementation by highlighting a result and impact achievements, gaps, strengths, weaknesses, opportunities and threats as well as the lessons learned;
- Propose recommendations/solutions to address the issues identified;
- Propose a strategy document for ABS development over the next five years, including a mechanism for monitoring/evaluation, financing and gender integration and mainstreaming;
- Validate the new strategy and its ABS action plan, by organizing consultation and restitution workshop with the stakeholders concerned;
- Facilitate a capacity-building workshop for stakeholders in the national biodiversity coordination mechanism.

# **III.EXPECTED RESULTS**

The following results are expected from this study:

- A strategy for the integration of the Nagoya Protocol on ABS into the country's NBSAP
   III iteration is proposed
- The implementation of the actions and activities planned in the 2012 ABS strategy and its action plan are evaluated;
- Constraints/difficulties encountered in the implementation are identified and analyzed and relevant recommendations/solutions are proposed;
- A country ABS strategy for the next five years is proposed;
- The implementation, financing, monitoring/evaluation, and gender mainstreaming mechanism is proposed;
- The National ABS strategy and action plan is validated during a stakeholder workshop
- The capacities of the actors of the national biodiversity coordination mechanism on the new ABS strategy and action plan are strengthened.

# IV. METHODOLOGY

The consultant will work under the supervision of the Project team (Project National Director, Project ABS Lead Technical Expert, Gender-Responsive Monitoring, Evaluation and Learning/KM Specialist), and in close collaboration with the ABS Taskforce of MINEPDED and the CBD focal point. The approach to the implementation of this study will be as follows:

- An initial scoping meeting with the consultant, the PMU and the ABS Taskforce of MINEPDED;
- The elaboration and submission of the methodology by the consultant for validation;
- Analysis of reports and findings from the implementation of the 2012 ABS strategy and its action plan;

- Interview with key stakeholders including relevant ministries, NGOs, private sector, local communities, Traditional Rulers, academic/research institutions;
- a field mission to collect data. The said mission will have to respect the following principles;
  - ✓ A participatory and inclusive approach, involving key stakeholders of the ABS in Cameroon, including decentralized services of the administration concerned, indigenous people and local communities (IPLCs), the mayors, academic research institutions, the private sector, civil society organization;
  - ✓ A gender approach involving at least 40% of women in data collection;
  - ✓ A human rights-based approach respecting human rights principles (universality, invisibility, equality, non-discrimination, participation, responsibility);
  - ✓ An evidence-based approach using reliable and relevant sources of information and applying rigorous and adapted analytical methods;
- A meeting to present the draft 0 report to the ABS task force;
- A workshop for the restitution and validation of the deliverables and the strengthening of the capacity of the national biodiversity coordination mechanism.
